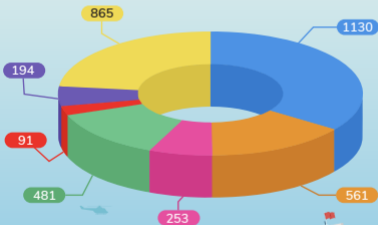
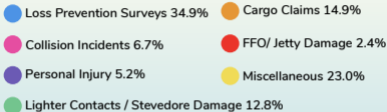
BANGLADESH'S SEA PORTS
